









In the latter case, the Data Source is the Client.</p>

	<p>PROVISION OF DATA</p> <p>The Data is required to prepare and/or execute the contract. Any refusal to provide the data therefore makes it impossible to enter into the contract and/or perform the contractual obligations.</p>

	<p>DATA RECIPIENTS</p> <p>The data may be transferred to external parties operating as Data Controllers, such as, by way of example, supervisory and control authorities, law firms and generally speaking any public or private body authorised to request the Data.</p> <p>The Data may be processed on behalf of the Data Controller by external parties designated as Data Processors that perform specific activities on behalf of the Data Controller, such as, by way of example, accounting, tax and insurance duties, the sending of correspondence, and income and payment management, etc.</p>

RIGHTS OF THE DATA SUBJECT - COMPLAINT TO THE SUPERVISORY AUTHORITY

The Data Subject may contact the Company by e-mail at the address valsoia@legalmail.it to ask the Company for access to the Data concerning them, for it to be erased, for Data to be rectified where inaccurate, for incomplete Data to be completed, for processing of the data to be limited in the cases provided for by GDPR Article 18, and to object to its processing, on grounds relating to their personal situation, in cases where the Data Controller has legitimate grounds.

Moreover, in cases where the processing is based on consent or contract and is performed using automated means, the Data Subject has the right to receive the Data they have provided to the Controller in a structured, commonly used and machine-readable format, and if technically feasible to transmit those Data to another Controller without hindrance.

The Data Subject has the right to lodge a complaint with the competent Supervisory Authority in the Member State of their habitual residence, place of work or place of the alleged infringement.

The Data Subject has the right to withdraw their consent for marketing purposes at any time and to object to the processing of their Data for said purposes. Data Subjects who prefer to be contacted for the aforementioned purposes exclusively using traditional contact methods have the option of objecting only to receiving communications sent using automated means.
